#### **RCX GLOBAL: Solutions of Equity Fund Management**

Founded in Bulgaria in 2016 by Roumen Dimov, RCX Global Equity Fund originally operated under the name RS Assets. In 2020, the company expanded its operations by integrating Capital Market Technology to support its tech-related activities.

In February 2024, RCX Global launched its first equity fund, K1, offering investment, consultancy, and asset management services with \$11.4 million in capital under management. By June 2024, the company introduced the K2 Equity Fund, adding an additional \$10 million in assets under management (AUM). The K1 Fund concluded the previous trading year with a gross ROI of 62.75%, surpassing the performance of global hedge funds. The K2 Fund achieved a 30% gross ROI from June 2024 to mid-March 2025, with the fund set to close in June 2025.

In February 2025, RCX Global began the new trading year with \$20 million AUM and secured the FSA Asset Management Licence in Seychelles. The fund currently operates with offices in Bulgaria, the UAE, Seychelles, and Andorra.

In collaboration with its legal team, RCX Global is in the process of securing a minimum of \$40 million in Lloyd's Capital Protection. The long-term goal is to grow the fund to \$500 million and, alongside this growth, to establish stronger partnerships with banks and liquidity providers. Furthermore, the company aims to expand the minimum capital protection it offers as part of its development strategy.
